**STANDING ORDER No.9**

**SUBJECT: CONSTITUTION OF AUROVILLE TOWN DEVELOPMENT COUNCIL  
ADVISORY GROUP (TAG):**

**W**hereas the Governing Board constituted the Auroville Town Development Council (TDC) for the purpose of implementation of the Auroville Master Plan vide Standing Order No. 6/2011 dated 01-05-2011.

**W**hereas Article 7 of the said Standing Order provides for the constitution of a TDC Advisory Group (TAG) comprising up to 7 members including the Director, Town and Country Planning, Government of Tamil Nadu, to advise the Governing Board and the Town Development Council on matters relating to the Master Plan.

**N**ow therefore the Governing Board, in terms of Article 7 of Standing Order No. 6/2011 dated 01-05-2011 constitutes the "Town Development Council Advisory Group" (hereinafter referred to as "TAG") as follows:

**1. Membership of TAG:**

- **Dr. Harjit Singh Anand IAS** (*Retd.*) - *Co-President, EuroIndia Centre; Chairman, Glownet Knowledge Services and former Secretary, Ministry of Housing & Urban Poverty Alleviation, Government of India;*
- **Mr. Ravi Chaudhry** – *Chairman, CeNext Consulting & Investment Pvt. Ltd;*
- **Mr. G. Dattatri** – *former Chief Town Planner, CMDA, Chennai;*
- **Mr. Toine van Megen** – *Co-Founder, Auroville Consulting;*
- **Mr. K.T. Ravindran** - *Head of the Department Urban Design –School of Planning and Architecture in Delhi;*
- **Mr. Aromar Revi** - *Director, Indian Institute for Human Settlements.*
- **Addl. Director / Joint Director Town & Country Planning, Government of TamilNadu**

**2. Expenses of TAG**

The expenses of the TAG shall be met out of the budget of the Town Development Council.

**3. Meetings of TAG**

The TAG shall hold at least two meetings per annum with the Town Development Council. The dates and venue of such meetings shall be decided in consultation with the Chairman, Town Development Council.

**4. Amendments to the Standing Order**

The Governing Board, in consultation with the Town Development Council may amend, from time to time, any or all of the provisions of this Standing Order.

This Standing Order is issued with the approval of Chairman, Auroville Foundation and shall come into force with immediate effect.
