Auroville Foundation invites sealed tenders for the sale of timber species types of (Acacia/ Pencil, Neem, Khaya Seneghalensis (Siventhenia), Eucalyptus ticocarpus (Thailaaram), Hardwickia binate (Atcha), Peltophorum pterocarpum(service tree), Caesalpinia pulcherrima (Mayil Konnai), Tamarindus indica (Pulian) through an "Short term tender cum open auction". Sealed tenders /offer bid are invited from the eligible individuals/contractors/firms/societies who are eligible as per the terms and conditions on or before 19/05/2025 at 5.00 PM. The Tender will be opened on 21/05/2025 at 11.00 AM in the Conference Hall, Auroville Foundation Office. Therefore, if the price is not satisfied by the tender committee the open auction will be conducted in the presence of the available tenderer.

The tender document shall be submitted to the above said office in person or by post or any other communication after duly filled in and signed along with Demand draft or Earnest Money Deposit. Tender not accompanying application fees and or EMD would be summarily rejected.

SEETHARAMAN OFFICER ON SPECIAL DUTY AUROVILLE FOUNDATION The timbers of (Acacia/ Pencil, Neem, Khaya Seneghalensis (Siventhenia), Eucalyptus ticocarpus (Thailaaram), Hardwickia binate (Atcha), Peltophorum pterocarpum(service tree), Caesalpinia pulcherrima (Mayil Konnai), Tamarindus indica (Pulian) have been segregated into logs based on tree size and is currently stored in two designated yards under the Auroville Foundation land. The total quantity logs available is 1000 tons (approximate). Interested parties may inspect the available timber at the yard during office hours, from 9:30 AM to 5:30 PM until 19/05/2025 at 5.00 PM to know the quality of material, location and terrain, for which they intend to submit tenders and satisfy themselves.

Terms and Conditions:

- The tender application fee will be Rs.250/- (Rupees Two Hundred and Fifty only) not refundable.
- 2. Bidders may participate for one or more logs. The rates/values will be finalized individually through the auction, based on the 'as-is-where-is' condition of the timber.
- The log details of (Acacia/ Pencil, Neem, Khaya Seneghalensis (Siventhenia), Eucalyptus ticocarpus (Thailaaram), Hardwickia binate (Atcha), Peltophorum pterocarpum(service tree), Caesalpinia pulcherrima (Mayil Konnai), Tamarindus indica (Pulian) are provided in Annexure-II.
- 4. The tender received after the last date and time of submission will not be entertained and be summarily rejected.
- 5. An EMD (Earnest Money Deposit) amount of Rs. 1,00,000/- has been fixed. The EMD will be refunded to the unsuccessful tenderers. The DD or EMD should be drawn in favour of "The Secretary, Auroville Foundation". The tender not accompanied by EMD will be summarily rejected.
- 6. The successful tenderer shall pay a security deposit amounting to 10% of the total tendered amount, and the EMD will be refunded to the tenderer with 30 days.
- 7. The Technical bid and financial bid details are provided in the Annexure-III & IV.
- 8. This Tender Committee has right to accept or reject any or all tenders with or without assigning any reasons thereof.
- 9. Canvassing in any form will disqualify the tenderer from participating in the tender process, and the tender will be rejected.
- 10. If two or more tenderers offer equal and acceptable amounts for the logs, the final decision shall be made either through negotiations or by drawing logs, in the presence of the tenderers, as determined by the Tender committee.
- 11. The successful tenderer shall clear all the stock or logs within 30 days, failure to do so will result in forfeiture of the EMD amount.

- 12. The selected tenderer shall execute an agreement in Rs.100/- non-judicial stamp paper, and pay the auction value from the date of order confirmation of Tender/ auction.
- 13. Any illegal acts or acts attracting punitive action, in the licensed premises comes to the notice of the Auroville Foundation Management, the contract is liable to be terminated would result loss of the money deposited and no refund will be entertained. This apart appropriate action would initiate for such misconduct.
- Any disputes arising shall be subject to the jurisdiction of the Villupuram District Court, Tamil Nadu.
- 15. Any damages to Auroville Foundation property during the removal shall be borne by the bidder.
- 16. The contractor shall be held responsible for any loss or damage arising out of the nonobservance of the terms and conditions mentioned above.
