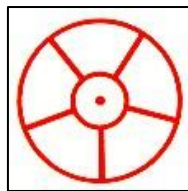

Sealed tenders /offer bid are invited from the eligible individuals/contractors/firms/societies who are eligible as per the terms and conditions on or before 28/01/2026 at 5.00 PM. The Tender will be open on 30/01/2026 at 11.00 AM in the conference hall, Auroville Foundation office.

Interested parties are invited to participate in the tender as per the terms and conditions stipulated in the “**Rate Contract document**”. The timbers of (Acacia/ Pencil, Neem, Khaya Seneghalensis (Siventhenea), Hardwickia binata (Atcha), (**Mixed Firewood**- 5 inches diameters only) and (Sulli Veeragu- diameters ranging from 1 to 2 inches only) have been segregated into logs based on species type and is currently stored in two designated yards under the Auroville Foundation land. Sealed tenders /offer bid are invited from the eligible individuals/contractors/firms/societies who are eligible as per the terms and conditions on or before 28/01/2026 at 5.00 PM.

Terms and Conditions:

1. Bidders may participate for one or more logs. The rates/values will be finalized by the tender committee, based on the 'as-is-where-is' condition of the timber.
2. The log details of (Acacia/ Pencil, Neem, Khaya Seneghalensis (Siventhenea), Hardwickia binata (Atcha), (**Mixed Firewood**- 5 inches diameters only) and (Sulli Veeragu- diameters ranging from 1 to 2 inches only) are provided in **Annexure-II**.
3. The highest rate will be fixed by the Tender committee and sale of timbers / wood for all the interested parties is permitted by depositing value of timbers/ woods in advance.
4. This Tender Committee has right to accept or reject any or all tenders with or without assigning any reasons thereof.
5. Canvassing in any form will disqualify the tenderer from participating in the tender process, and the tender will be rejected.
6. The interested party shall lift and clear the allotted stock, as per the required quantity, within **10 (ten) days** from the date of advance payment.
7. Any illegal acts or acts attracting punitive action, in the licensed premises comes to the notice of the Auroville Foundation Management, the sale is to be terminated would result loss of the money deposited and no refund will be entertained. This apart appropriate action would initiate for such misconduct.
8. Any disputes arising shall be subject to the jurisdiction of the Villupuram District Court, Tamil Nadu.
9. Any damages to Auroville Foundation property during the removal shall be borne by the bidder.
10. The buyer shall be held responsible for any loss or damage arising out of the non-observance of the terms and conditions mentioned above.
